


Exchange Agreement MD DENMARK - _____

About us

Welcome; we are happy to work on exchanges with your RI-certified district or multidistrict. Multidistrict Denmark combines the five districts of 1440, 1450, 1461, 1470 and 1480. The MD has been involved in the Rotary Youth Exchange since the very beginning of the program in 1974 (and even before). We normally exchange around 100 Danish students abroad yearly, receiving just as many in our clubs, schools and homes. RYE is a cornerstone of Rotary Denmark, and we are proud of being among the top-ranked exchange programs in Denmark for many years. Compared to the number of citizens and RYE students, MD Denmark is probably one of the largest RYE programs in the world.



Exchanges

We might be brought to estimate an **exchange number** together, prior to any discussion between you and our districts, so that our multidistrict will coordinate each district exchange with your multidistrict/district.

We have to prepare ourselves, even if as for many countries, we will not be able to confirm firmly our LTEP exchanges before the end of February, which would be the **last limit** to ensure a safe organization for trips and visas.

Legal conditions

We comply with the Rotary International certification, caring for the students in the best possible manner – also regarding the student's personal data. Being an EU country, we are used to handling personal data following the GDPR legislation, only sharing data with the people who need it to run the RYE admin and always in compliance with the local laws. This follows the RI Application Form, which we sign as sponsor districts/multi-districts when accepting a new exchange student into the RYE program.

Rotary Youth Exchange Application Privacy Statement

If you are accepted into the long-term Rotary Youth Exchange program, this application and the information contained within will be shared with relevant Rotary entities including your sponsoring club and home district plus the district and club that will be hosting your exchange, according to the policies of these Rotary-certified sponsoring and hosting districts. This information may also be shared with others involved with conducting the program, including exchange counselors and host parents. Any personal data shared will be processed in accordance with all applicable laws.

Personal data will be processed only by authorized youth exchange officials. Your application will be secured and protected. When sharing any information from this application, only the portions which are appropriate and necessary will be provided to your host school, your medical providers and dentists, Rotary counselor(s), program coordinators and host parents.

Personal data will be retained only as long as needed to conduct the exchange program. This will include a temporary period after the conclusion of your exchange for administrative purposes such as complying with data retention requirements of applicable law; assembling district and regional exchange program summary reports and statistical tallies; completion of certification audits; and post-exchange follow-up communications for program evaluation. No sooner than two (2) years and no later than five (5) years following the originally-scheduled conclusion of your exchange, unless separately consented otherwise, your personal records will be destroyed according to the policies or practices of your sponsoring and hosting districts including paper shredding and/or purging of electronic data in compliance with the laws and regulations applicable for each participating location.

Students may request correction or deletion of personal data using the same contact information provided for submitting this application or by contacting the youth exchange chairperson for the applicable Rotary sponsor or host district.

Rotary International ("RI"), headquartered in Evanston, Illinois, USA, is the global organization that charters Rotary clubs. RI certifies Rotary Districts meeting standards for participation in youth exchange programs. RI will not receive a copy of this application.

Mental Health

We are highly reluctant to exchange students with a medical mental health history or ongoing issues such as e.g. depression, anxiety or ADHD. It is our experience that being an exchange student is highly demanding, and if you have already struggled with mental issues before arriving, we cannot support the student sufficiently. The student will most likely not have a successful exchange. Being a RYE student demands extra mental strength to handle homesickness, a new environment, new friends and many other demanding issues during the year.

Additions

(*) Specific conditions on a case-by-case basis can be agreed between districts prior of exchange out of the standard national conditions. No guarantee of approval.

(**) We could accept to add inbounds who would do their best to learn as much as possible Danish language before arriving. Some excellent online courses, even for free are to be found. Strongly encouraged.

Inbound Restrictions

- School participation is mandatory during the exchange year with demonstrated performance. School rules are to be respected.

- Attendance to (home country) online courses, competitions, entrance test, school or university exam out of their host country is absolutely not recommended for a successful exchange year, and special agreement should be discussed beforehand.

- Communication process has to be from participant to Youth Exchange host club officers and/or host district, prior to natural family or sponsor club.

Applications

- No handwritten Application File accepted.

- Applications can be shared according to GDPR restrictions. Links from Danish RYE database or YEAH/YoLEM or other RYE system according to coordination between country coordinators.

- Avoid sending Application Files on PDF within a standard e-mail or message. Better use a secured link or a secured file sharing application.

Data Protection

Our GDPR legislation in Europe, added to national laws, brings us to be extremely cautious with the data we share.

For example, it is **forbidden to share data** (on both sides of our exchange) of a European participant, so as for any minor (or extended <21), to a <u>non in-person identified</u> (in both districts) and <u>not involved</u> Rotarian or volunteer.

The volunteer has to be **duly involved** in this exchange, and the transmitted data (out of our district to district officers) has to be reduced to **the sole necessary** (medical goes to doctors, letters to family, etc...).

No data is allowed to be transmitted to so-called third-parties, except for legal reasons.

In fact, our AF, GF and participants / family data, are strictly to be kept by District chairs, District Youth Protection Officer, RYE officer (program coordinator). Part of the data, what is strictly needed, to host club YEO, host club president and host family.
