### **VISA APPLICATION FORM**

#### **General Visa Information**

On 1 October 1969, an Exchange of Notes on the Waiver of Visa Requirements was signed between the Government of the Republic of Korea and the Government of the Kingdom of Denmark. On the note Danish citizens can visit the Republic of Korea without visa for duration of up to 90 days or less if the purpose of the trip is for tourism. A person who wishes to work or to engage in profit making activities is kindly requested to apply for an appropriate entry visa.

You can visit the Visa section during working hour (9:00~12:00) with **NO appointment.**

**Visa Issuance takes about up to 2 weeks.**

- A valid passport & A passport copy
- A completed visa application
- A passport size photo (3.5”x 4.5” color)

## Visum procedure

### South Korea

---

- Fee: 280 DKK. (Single entry less than 90 days), **420 DKK (Single entry more than 90 days)**, 630 DKK (Multiple entry). The fees may vary based upon your country.

No fees for A-1, A-2, and A-3 applicants

\* Cash or Bank Check Only

\* 6 Month Validity Rule: It means that your passport should be valid for more than six months before you would be allowed to enter Korea. – **pas skal være gyldigt i mindst 6 mdr. efter tilbagekomst til DK**

**Visa application is not accepted via post with any reasons.**

**Fra Rotarys kontakt i South Korea har vi modtaget:**

So, we, our district officer, are going to propose to your student for this situation.

We are going to get an invitation letter from the City and District.

**Your student will apply for a visa to the Korean embassy in your country – Denmark.**

When you get the visa, it is okay to come in.

Then we will apply for an Alien card for permitting to stay more than 90 days.

**If the student could not receive it, we will pay for an outside country tour to renew the permission to stay.**

With this action, you must understand and agree about possibility denying.

This possibility is very rare, but it is possible. So, we want to make sure before you make any decision.
